Level II Section Information for Summer 2023, **ALL SECTIONS ARE TENTATIVE AND SUBJECT TO CHANGE**

Check your LOLA preferred email account, it is best to use your DCC email for communication in the course.

During the summer, NURS 129 and NURS 127 are offered

The curriculum plan for the 2nd semester, Level II, includes five courses: NURS125 (Nursing II); NURS 129 (Special Populations I); NURS 127 (Pharmacology II); PSYC 127 (General Psychology); and BIOL 211 (Microbiology). All five must be completed before enrolling in the 3rd semester nursing courses. **NURS 125 is not offered in the summer.**

SUMMER COURSES

Students who plan to enroll **this summer** may elect to enroll in a combination of courses with the understanding that there are pre and co-requisites that must be considered.

- NURS 127, **Pharmacology II** requires Nursing 113 and Pharm I as a prerequisite.
- NURS 129, **Special Populations I** requires Nursing 113 and Pharm I as a prerequisite, PSYC 127, General Psychology and NURS 127, Pharmacology II as a pre or co-requisites.

Registration for NURS 129 (Special Populations I) and NURS 127 (Pharmacology II) is **Thursday May 18th at 1300**. There are only online Pharmacology II sections. There are 3 sections for Pharm for a total of 90 spots.

The theory/class time for NURS 129 will be held **virtually** on Monday mornings from 0900-1100 and **in person** on **Tuesday June 6th from 1100-1300 and June 26th from 1000-1200 after exam 1**.

Testing for NURS 129 will be held in person at 0830 on June 26th, 0900 on July 17th, and the final exam will be July 24th at 0900. Kaplan testing will follow exam 2 on July 17th. The hours for July 17th are 0900-1300. All testing will be held at City Park campus.

Please plan for these days if you register for the course

Testing for Pharm 2 will take place on Monday afternoons on June 19th, July 10th at 1300 and the final is July 20th at 0900. All testing will be held at City Park campus.

Students enrolled in NURS 129 will take a **Medication Proficiency Evaluation (MPE) on Tuesday June 6th at 0900, City Park Campus, location TBD. You have to renew/pay for your exam-soft account for the semester in order to take this evaluation.** Your renewal will cover summer and fall semesters. The exam will include things you learned in Pharm 1 and Nursing 1.

If you are enrolled in NURS 127/Pharm 2 only, you will not take the MPE.

Students who have previously took NURS 129/Special Populations 1 (*Previously unsuccessful*) **must register for a different team/faculty member** unless given permission to do so by the level coordinator.

Nursing 129 (Special Populations I) has limited clinical facilities for students. The locations are River Oaks Hospital in Harahan, Ochsner/ St. Charles Behavioral Health Unit in Luling, and Northlake Behavioral Health in Mandeville. **All Nursing 129 clinicals are an 8-hour in person/week and an additional 4 hours of virtual/clinical time to complete the 12 hour/week requirement. If you can not participate in both the in person**

and virtual component, please do not register for the course. NURS 129 faculty will explain this in more detail. There are 42 spots for Nsg 129. **Classes will be held virtually via Zoom on Mondays from 0900 -1100, except for the first week and on June 26th. See calendar for additional details.**

Dr. Hoppe (Section 301) and Ms. Mose (Section 303) will have clinical on Tuesday in-person. Dr. Hoppe (Section 302) and Ms. Mose (Section 304) will have clinical on Wednesday in-person. The in-person clinical time is 0730-1530. The virtual component will be held after the in-person clinical. These clinical days will be 12 hours.

Ms. Leefe (Section 307) will have clinical on Tuesday in-person 0730-1530. Ms. Leefe (Section 308) will have clinical on Thursday in-person 0730-1530. Wednesday will be virtual clinical from 0900-1300 for both groups.

All students MUST submit your clinical paperwork to your clinical instructor (Castlebranch and clinical forms) by May 25th by noon. This is a facility mandate for students. If paperwork is not received, you could be dropped from the course.

Class starts on June 5th. On this day, you have class and orientation from 0830-1500.

All students enrolled in NURS 129 will be oriented to Level II on Monday 6/5 at 0830. This will be a Zoom, virtual orientation, and the link will be posted on the Canvas site. Monday, 6/5, class will be from 0900-1100 and Clinical orientation will be from 1200-1500. This is a mandatory all day event you are responsible to participate in for Nsg 129.

If you register for this course-YOU must be available from 9-3pm on July 17th to take the Kaplan exam, following exam 2.

Nursing 129 will have class Monday mornings from 0900-1100 (see calendar for exceptions). Exam 1 for Nsg 129 is June 26th at 0830. Exam 2 for Nsg 129 is July 17th at 0900, and the Kaplan Test will be given following the unit exam. The final exam is July 24th, starting at 0900.

The last day to drop without a W is June 12th -Census Day.
