

# Workforce Integrated Performance System (WIPS)

During the government shutdown, starting on or around November 3rd WIPS did not process and generate most reports as intended and as a result most attempts to upload and certify failed at some point in the process. Therefore, ETA is instructing users who attempted to upload their report between November 3rd and Noon ET on November 13th and did not certify will need to resubmit before certifying their report for PY 2025 Q1. To accommodate this resubmission process, ETA is allowing grantees additional time to submit and certify these reports, with a new due date of 11/28/2025 at midnight local time.
